Under the Regulation (EC) No 1907/2006 on the Registration, Evaluation, Authorization and Restriction of Chemicals known as REACH, the following substances were added to Annex XIV ('Authorization list') for environmental reasons with a sunset date of January 4th, 2021

- > 4-(1,1,3,3-tetramethylbutyl) phenol, ethoxylated (OPE)
- > 4-Nonylphenol, branched and linear, ethoxylated (NPE)

Further use of products containing these substances is permitted in the EU as the use is subject to an exemption, such as the exemption for scientific research and development and to analytical activities using in vitro diagnostic (IVD) medical devices (as defined in Directive 98/79/EC) according Article 56(3) of REACH (= analysis carried out under controlled conditions with an OPE/NPE volume <1 tons/year per legal entity, see Q&A 1442 of the European Chemicals Agency), hereinafter referred to as the "SRD Exemption". This exemption will ensure your continued use of products, see table 1, containing OPE's.
